

## 2023 Kansas Statutes

**17-2330. Capital stock.** No such corporation shall be organized with a capital stock of less than twenty-five thousand dollars (\$25,000), which shall be paid into the treasury of the corporation in cash before the corporation shall be authorized to transact any business other than such as relates to its organization.
