1 AN ACT concerning alcoholic beverages; relating to the employment of
2 certain individuals by licensees under the club and drinking
3 establishment act; amending K.S.A. 41-2610 and repealing the existing
4 section.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 41-2610 is hereby amended to read as follows: 41-
8 2610. ~~(a)~~ It shall be unlawful for any licensee or holder of a temporary
9 permit under this act to:

10 ~~(a) (A) (i)~~ Employ any person under the age of 18 years in connection
11 with the serving of alcoholic liquor.

12 ~~(b) (2)~~ Employ knowingly or continue in employment any person in
13 connection with the dispensing or serving of alcoholic liquor or the mixing
14 of drinks containing alcoholic liquor who has been adjudged guilty of a
15 felony or of any crime involving a morals charge in this or any other state,
16 or of the United States.

17 ~~(c) (3)~~ Employ knowingly or to continue in employment any person
18 in connection with the dispensing or serving of alcoholic liquor or mixing
19 of drinks containing alcoholic liquor who has been adjudged guilty of a
20 violation of any intoxicating liquor law of this or any other state, or of the
21 United States, during the two-year period immediately following such
22 adjudging.

23 ~~(d) (4) (b)~~ In the case of a club, fail to maintain at the licensed
24 premises a current list of all members and their residence addresses or
25 refuse to allow the director, any of the director's authorized agents or any
26 law enforcement officer to inspect such list.

27 ~~(e) (5) (c)~~ Purchase alcoholic liquor from any person except from a
28 person authorized by law to sell such alcoholic liquor to such licensee or
29 permit holder.

30 ~~(f) (6) (d)~~ Permit any employee of the licensee or permit holder who
31 is under the age of 21 years to work on premises where alcoholic liquor is
32 sold by such licensee or permit holder at any time when not under the on-
33 premises supervision of either the licensee or permit holder, or an
34 employee who is 21 years of age or over.

35 ~~(g) (7) (e)~~ Employ any person under 21 years of age in connection
36 with the mixing or dispensing of drinks containing alcoholic liquor.

(c) Knowingly employ or continue to employ any person in connection with the dispensing or serving of alcoholic liquor, or the mixing of drinks containing alcoholic liquor, who has been adjudged guilty of three or more violations of any intoxicating liquor law of this or any other state, or of the United States, within the immediately preceding five years.
